
In terms of para 4.2 of the Bye-laws of Omaxe Heights (Faridabad) Residents Welfare Association (Regd.), the Executive Committee have appointed the Election Committee, consisting of following members to conduct the election of Collegium for the year 2014-15:

1. Shri Arun Pottirayil, Chief Election Officer 302, Highcliff Tower, Omaxe Heights, Fdb.
2. Shri Jitendra Khare, Returning Officer 105, Tuntex Tower, Omaxe Heights, Fdb.
3. Shri Om Prakash Gautam, Returning Officer 606, Equator Tower, Omaxe Heights, Fdb
4. Shri Predeep Kumar Sahu, Returning Officer 303, Menara Tower, Omaxe Heights, Fdb

According to the provisions of the constitution of the affairs of the society, Collegium is to be comprised by one representative from each college.

General procedure for the election for the member of Collegium as decided in the Executive Committee meeting will be as under:

1. One member can cast one vote and / or contest the election for the member of Collegium if his/ her name is appearing in the voter list available with the returning officer. Any objection with relate to members list should brought to the notice of Returning officer latest by 20th April 2014. Returning officer will resolve the matter latest by 23th April 2014. The decision of Election committee will be final.
2. Member shall represent the College provided his / her membership is allotted for the flat in that College.
3. Members of College will elect the representative of their College only.
4. Votes will be polled only by the member, according to the authentic list with Election Committee.
5. Members can reject all the members contesting the election by choosing "none of them" option.

6. The contesting candidate can depute only one polling agent on the written and signed authorization slip by the candidate.

7. The programme of the election is as under:


(i)	Collection of nomination forms and submission of nominations forms with fee of Rs.200/- (non-refundable) at RWA Office, Mark Tower, Omaxe Heights between 7.00 PM to 9.00 PM	25.4.2014 to 27.4.2014
(ii)	Announcement of names of eligible candidates at RWA Office, Mark Tower, Omaxe Heights between 7.00 PM to 9.00 PM	28.4.2014
(iii)	Withdrawal of names at RWA Office, Mark Tower, Omaxe Heights between 7.00 PM to 9.00 PM	29.4.2014
(iv)	Final List of Contestant at RWA Office, Mark Tower, Omaxe Heights between 7.00 PM to 9.00 PM	30.4.2014
(v)	Conduct of elections from 9.00 AM to 1.00 PM at RWA Office, Mark Tower, Omaxe Heights, Faridabad	04.5.2014


8. Results will be announced as soon as the counting is over on the same day.
